### Cookies

A cookie is a small text file that is sent along with pages of websites and through your browser on your computer, tablet or mobile phone is saved. details, the association will pass along this removal to all organisations who have gotten this information from us.

### **Security of personal details**

The association will take appropriate measures to secure your personal details against loss, unauthorized access, publication and unlawful processing. This way we make sure that your personal details can only be reached by the necessary people, your personal details are shielded and that our safety measures are regularly checked.

### **Minors**

In case you want to register as a minor, you have to get explicit approval of your parent or guardian.

### **Links to different website**

The website can contain links to different websites. This privacy statement is only applicable to the websites of the association. Different websites might use a different privacy statement. The association recommends you to read the privacy statement of any other sites.

### **Changes in the privacy statement**

The association occasionally updates the privacy statement. The most up-to-date version will always be on the website. The association recommends you to check the privacy statement regularly. For important changes, the association will inform you through email and the website.
